## HUNTINGTON BANCSHARES INCORPORATED INCREASES ITS PRIME RATE TO 6.25 PERCENT

**COLUMBUS, Ohio** – Huntington Bancshares Incorporated (Nasdaq: HBAN) announced that its prime rate is increasing from 5.5 percent to 6.25 percent, effective September 22, 2022.

The rate was last changed on July 28, 2022, when Huntington increased its prime rate from 4.75 percent to 5.5 percent.
